This contract RIDER entered into as of _____, 200____, by and between HEAR IN RHODE ISLAND, INC, hereinafter called the "AGENT" representing the band, FOREVER YOUNG and _____ hereinafter called the "PURCHASER". Therefore it is mutually agreed by and between the AGENT and PURCHASER as follows:

1.) ADVERTISEMENT: ARTIST will receive billing as "FOREVER YOUNG: A Tribute to the Music of Neil Young" in any and all releases and paid advertisements. Any television, radio or press interviews and appearances must cleared through HEAR IN RHODE ISLAND.

2.) PAYMENT: All payments received hearunder shall be made in United States currency. The PURCHASER guarantees that contracted amount represents actual amount paid to the AGENT. PURCHASER assumes all financial responsibility for liens, taxes, withholding, border broker, work visa, baggage overage charges and all other fees above contracted figure.

3.) OFF-STAGE AREA: PURCHASER agrees to provide at no cost to the ARTISTS, one clean, lockable, dressing room/prep area to accommodate eight persons. The room shall be dry, well lighted, appropriately heated or cooled, with access to a clean lavatory. PURCHASER agrees to be solely responsible for the security of all items in this room and shall keep unauthorized personnel from entering said area. PURCHASER agrees to also provide BOTTLED WATER, 12-24 SAM ADAMSor BUDWIESER BEERS and lite fare (ex. healthy snacks) and/or meal buy-outs of \$20 pp.

4.) ON-STAGE AREA: PURCHASER agrees to provide at no cost to the ARTISTS 14 bottled waters and 7 towels.

5.) SOUND: PURCHASER agrees to provide a first class professional sound and lighting system appropriate to the venue size. Purchaser must provide a sound and light technician for sound check and during the entire performance. PURCHASER must have sound system ready and functional with sound and light technicians on stage at the time of the load-in and sound check. See STAGE PLOT for stage details.
